In 2017 the organization continued to achieve fantastic legal outcomes for our clients. In line with our strategy refinement ISLP has continued to evolve as a leader in the pro bono space. In the past year, ISLP has responded to the needs of clients by moving forward with ambitious programs in some of our launched our Gambia program. ISLP was on the ground a month after the changeover of government. Based on the preliminary work the organization had done in country, we were able to launch a wide-ranging program of support for the government. Through this program, which has been supported by several funders, including the ALSF and the Canadian government, we have embedded a fellow with the Ministry of Justice. We have expanded our project globe the everything from telecommunications to Public Private Partnerships.

Based on the success of the Gambia project, we are now preparing similar programs in other jurisdictions. As an organization, one of our key strengths is being both nimble and scalable. We have used this strength to our clients' advantage, often being first on the ground during a time of significant change, and providing just in time support for new or transitional governments. In addition, the ability to embed staff or volunteers with ministries in-country has allowed us to be responsive to our client's needs in real time, which has strengthened our relationships with our clients and has allowed us to move forward quickly in fast changing environments.

In turn, this experience has allowed us to be more forward-thinking with some of our partners and those in our "ecosystem". Our practical experience advising governments and civil society has made us a more valuable partner for development banks and other organizations, and has given us an increasing voice in policy debates.

WHAT WE DO

INVESTMENT & TRADE

ISLP assists least-developed country governments build their economies through well-structured foreign investment, increased trade opportunities and establishment of fair revenue streams. Beyond government clients, trade work also supports non-profit organizations and selected SMEs to help improve entrepreneurs' access to trade opportunities. This often takes the form of legal advice or capacity-building programs.

ANTI-BRIBERY & CORRUPTION

ISLP assists government and civil society clients to investigate, report on, prosecute, and otherwise reduce the corrupt practices that have corrosive economic, political and social impacts. ISLP seeks to promote transparency, integrity and accountability in public and private institutions.

TAX

ISLP enables developing nations to build and improve fair and effective tax systems and to generate the funds they need to finance development projects and provide basic public services. ISLP provides technical expertise and practical experience to help countries build national tax policy, strengthen tax administration capacities, and handle international tax treaty negotiations effectively.

COMMUNITY-INCLUSIVE DEVELOPMENT

ISLP's Community-Inclusive Development program empowers civil society to more effectively represent the rights, needs, and interests of communities at risk of being negatively impacted by large-scale development projects. We provide civil society advocates access to the expertise and industry savvy of high-level lawyers. Our work helps civil society organizations to identify leverage points and understand what recourse options may be available and/or have been available in similar contexts elsewhere. ISLP also aims to improve the ability of project proponents to make viable and sustainable investments through enabling constructive and participatory community-corporate engagement around projects.

ATURAL RESOURCE MANAGEMENT

ISLP supports governments in reviewing, analyzing, and negotiating contracts with regard to the exploration, development, and management of their natural resources. Additionally, ISLP helps design and draft legal and regulatory frameworks that encourage good governance, fair returns, transparency, and accountability. ISLP also helps build the capacity of government officials to better enable them to conclude foreign investment contracts and generally manage the sector in accordance with best practices.

2017 PROGRAM WORK

COMMUNITY-INCLUSIVE DEVELOPMENT

In 2017 ISLP's Community-Inclusive Development team continued active projects from last year and embarked on new projects to advocate for equitable benefits from the development of natural resources, as well as the protection of adjacent communities, including:

- Provided comparative and best practice analysis on Public-Private Partnership legislation and regulatory frameworks in Latin America.
- Organized major in-country training sessions in Myanmar providing public interest lawyers practical skills for advocating for their community clients and for community members affected by Special Economic Zone development using the new Myanmar Guidelines for Community Consultation as a reference point.
- Mapped corporate structures of tenant companies of the Thilawa Special Economic Zone to help identify additional leverage points or legal options for local partners and their communities.
- Delivered a training program for ISLP volunteers to familiarize themselves with the complexities of representing marginalized communities threatened by large-scale resource development.

NATURAL RESOURCE MANAGEMENT

ISLP supported governments in undertaking sound and beneficial Natural Resource Management Program work in 2017 through:

- Reviewing, negotiating or helping to terminate multi-million dollar transactions in the extractives, infrastructure, and telecommunications sectors in jurisdictions such as Afghanistan, The Gambia, Malawi, and Tanzania.
- Providing pre-arbitration advice to an LDC government on an extractives licensing dispute.
- Drafting and reviewing legislations for the Republic of Guyana on cybercrime & electronic transactions, and The Gambia's Public-Private Partnerships Act.
- In-country trainings for government officials and government negotiation teams:
 - On Public-Private Partnerships, three workshops in Zambia;
 - On Oil & Gas, one regional sub-Saharan workshops held in Tanzania; and
 - On General Negotiation Skills and Trade Negotiation skills, one regional sub-Saharan workshops held in Tanzania
- Signing of a Partnership MoU with GIZ under the CONNEX Initiative.

TAX

ISLP has undertaken work in our Tax focus area throughout 2017 to great effect. A combination of theoretical and advisory legal work has been provided to encourage developing nations to build and improve fair and effective tax systems and to generate the funds they need to finance development projects and provide basic public services:

- Embarked upon a major new project to promote better double tax treaty policy in anglophone Africa to build capacity of tax administrations on treaty negotiation and reform.
- Facilitated a NEPAD regional dialogue in Yaounde, Cameroon for African officials on tax and contract negotiation issues in the extractive industries.
- Advised on engagement with the OECD "Global Forum on Transparency and Exchange of Information for Tax Purposes" and provided legal assistance on a range of issues including provisions in concession agreements, the taxation of corporate reorganizations, and the development of new legislation in Liberia.
- Published a practical guide on how to capture capital gains tax on the offshore indirect transfer of extractives projects.
- Developed strategies at both national and regional levels to address the inequitable taxation in African countries.

INVESTMENT & TRADE

ISLP's Investment & Trade team supports developing governments to attract investment and negotiate fair trade agreements, helping to fund the provision of basic goods and services, as well as strengthen state institutions. Program work in 2017 included:

- Organized and ran Commercial Law Training Programs in South Africa and Zimbabwe.
- Continued support for the assessment framework evaluating viability for the exportation of peanuts, cassava, refined copper and precious stones under the African Growth and Opportunity Act, Zambia.
- Assisting the Foundation for a Unified Business Law in Africa (FOUBLA) on the English commentary of the Organization for the Harmonization of Business Law in Africa's (OHADA) uniform laws.
- In South Africa and Zimbabwe, provided commercial law training to lawyers from traditionally disadvantaged backgrounds to enable them to participate more fully in their country's economic development.



ANTI BRIBERY & CORRUPTION

ISLP's 2017 Anti-Bribery & Corruption work remained focused on transparency, integrity and accountability:

- Continued and extended our commitment to Albania's justice reform program. ISLP delivered courses on juvenile justice and organized crime for judges of the court of first instance and serious crimes court.
- Expanded our high level advisory support to the newly formed Malagasy Commission for Judicial Integrity, Madagascar.
- Supported the office of the Attorney General by reviewing the Guyana Cyber Crime Bill and Electronic Transactions Bill.

MEDIA LAW

In relation to Media Law work, ISLP continued an 18 year record of providing pro bono legal services to protect and promote freedom of expression and the rights of citizens to be informed. ISLP's Media Defence experts assist media outlets, NGO's, journalists and bloggers and work to enact systematic legal reforms.



CASE STUDY

COMMUNITY INCLUSIVE DEVELOPMENT

THE BRIEF: Empowering Community and Civil Society Participation in Development Decisions in the Andean Region

2017 ISLP was awarded grant ln funding to extend our work to the Andean Region. Undertaking this project we provided strategic legal support, research, and analysis to four civil society organizations in the Andean region (Fundacion Construir in Bolivia, Mater Fundacion Terra in Ecuador. and Paz y Esperanza and Derecho. Ambiente y Recursos Naturales (DAR) in Peru in order to strengthen civil society and community participation in large-scale development in the region.

The first objective of the work was to increase community consultation and participation in the planning and implementation of large-scale development projects in Bolivia, Peru, and Ecuador. The second objective was to improve the capacity of local lawyers, community leaders, and civil society representatives to represent community priorities vis-àvis corporate and government interests. ISLP conducted, among others, а comparative legal analysis of Public Private Partnership laws and regulations in the region, and conducted research to unveil the complex corporate structures behind palm oil and logging operations of a national conglomerate. ISLP also began planning for а high-level training for CSO representatives in Bolivia and a regional convening in Ecuador.

Postscript: During 2017 legal volunteers were contacted and ISLP staff planned capacity- building events. Those events will take place with CSOs in 2018 to provide participants the tools to understand the entire lifespan of an infrastructure project. The event will help participants structure advocacy campaigns, build more effective strategies to engage with project proponents, and apply pressure across international leverage points.



SPOTLIGHT: GAMBIA

THE CLIENT: Ministry of Justice, Government of The Gambia, PPP Unit THE BRIEF: Support The Gambia's Return to Democracy after the Transition of January 2017

n January 2017 The Gambia successfully transitioned to its first democratically elected government in 20 years.

In the immediate aftermath, it was clear the incoming Government would require substantial legal assistance which ISLP was uniquely qualified to provide. As a result of our successful early engagement, ISLP executed a wide-ranging Memorandum of Understanding with the Ministry of Justice, governing the provision of legal assistance, and established long-lasting relationships with other governmental ministries and agencies, including the Directorate of Public Private Partnerships within the Ministry of Finance and Economic Affairs.

The relationship between ISLP and the Government has only strengthened during the course of 2017. In November 2017, thanks to a grant received by the the Government of Canada, acting through the Department of Foreign Affairs, Trade and Development within the Ministry of Foreign Affairs, ISLP has seconded one of its legal fellows to the Ministry of Justice. The fellow worked side by side with Gambian State Counsels to develop capacity building trainings with a view of enabling the Ministry of Justice to deliver on its mandate of supporting The Gambia's return to democracy and ensuring government accountability.

In addition, our experts have been providing direct legal assistance to the Ministry of Justice on a daily basis, implementing mentoring processes and developing resources to strengthen the Ministry's institutional processes. Similarly, ISLP has received the support of the African Legal Support Facility for the establishment of a program designed to increase the capacity of the Government on a wide range of transactional matters, focusing, in particular, on the creation of a strong legal framework for public private partnerships.



SPOTLIGHT: ALBANIA

For the last few years, Albania has been a key jurisdiction for ISLP's Anti-Bribery and Anti-Corruption Focus area. In 2017 the UK based team, leveraged their expertise to deliver an even more comprehensive program than the five training sessions the team conducted in 2016.

n keeping with ISLP's mission the program was designed to strengthen the capacity of young judges, prosecutors and advocates in areas of law critical to Albania's justice reform program EU accession path.

ISLP-UK designed and delivered а specialist legal training program in response to requests from the Albanian Magistrates, the Court for Serious Crimes and the Albanian School of Advocates. Drawing on previous experience and applying lessons learned from earlier initiatives, the courses were highly by the focused on topics identified beneficiary institutions and tailored to the specific learning and professional development needs of each recipient audience. For each training ISLP recruited a combined team of international and local law experts who worked together to present the course topics in the context of international best practice and the Albanian legal system.

The Program forms part of a structured and long-term commitment to Albania building on training expertise developed by ISLP over more than a decade and informed by learning derived from the series of five trainings delivered in Albania in 2016. Areas of focus for the 2017 program included financial crime, serious fraud, and organized crime, as well as commercial and practical skills training to prepare Albanian legal professionals to act on justice reform measures and respond to the demands created by emerging new justice institutions.

The team's commitment to their anti corruption brief in Albania also saw them undertake further programs including the Euralius Project, the prisoner transfer agreement project and their work on juvenile justice.

SOCIAL IMPACT INVESTING

Recognizing the critical shortage of philanthropic and non-aid funds needed to support pressing global challenges, achieve the Sustainable Development Goals, and ultimately create a more inclusive world, ISLP's Impact Investing Program seeks to enable and stimulate impact investment opportunities and support access to finance and private capital for innovative enterprises and nascent investment vehicles that embed environmental and social goals.

SUPPORTING INNOVATIVE ENTERPRISES

In 2017, we continued to provide legal support to select impact investing ecosystem stakeholders who might not otherwise have access to high-level legal support.

We started to collaborate with a number of Rockefeller Foundation's Zero Gap portfolio grantees. The goal of providing pro bono legal support to these early stage investment vehicles is to enable them to allocate its resources more efficiently, so that they focus on the global issues they are aiming to address.

ISLPs' work with small to medium-sized enterprises and nascent investment vehicles that embed social or environmental benefits into their business models aims to complement the work we do in all of our focus areas and ultimately advance our mission towards more inclusive development.

IMPACT INVESTMENT TRAINING – NAIROBI

In November 14-15, 2017 ISLP in collaboration with the Law Society of Kenya and the Strathmore University launched in Nairobi, Kenya a pilot training on "Negotiating Impact Investings." This two-day, CPD case study driven workshop was hosted at the Strathmore University and was led by experienced experts in the impact investment field.

The training examined a basic impact investment deal from first capital raise through exit, while highlighting the terms unique to impact investing. The training also aimed to highlight both substantive law applicable to impact investing and the technical skills needed to serve as effective counsel to foreign investors. The trainers in the workshop were Acumen, the African Legal Network, Beyond Capital Fund, Debevoise & Plimpton LLP, Sunfunder, Factor[e], TASLAF Uganda, TrustLaw, and Village Capital.

LPT EUROPEAN CONVENING & THIRD ANNUAL CONVENING

The Legal Practitioners Track (LPT), an initiative that ISLP and the Global Impact Investment Network had from 2015 to 2017, held two convening meetings during 2017. These meetings supported the LPT's principle goal of bringing highlevel legal practitioners together to share legal understanding and develop legal innovations to address new and complex issues and investment impediments. The attendees to these events were senior legal practitioners in the impact investment field. Various types of actors were present, such as, law firms, foundations, development financial institutions, impact investors and academics.

- Continue efforts to support the post Mugabe government and civil society organizations in Zimbabwe.
